- MSWG shall not be held responsible for incidental, consequential, or any damages arising out of or in connection with the use of Services or materials provided hereunder;

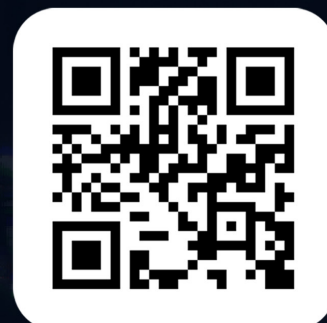

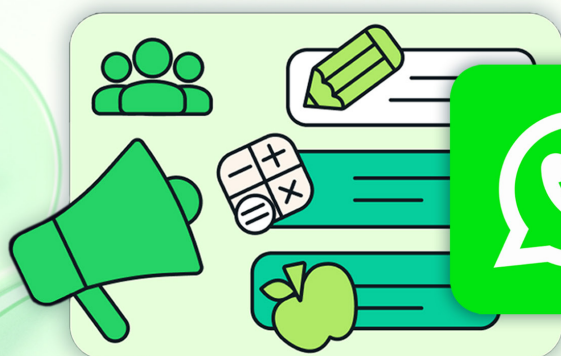
